In terms of Railway Board's letter dated 30/06/2020, on the above subject matter, CMPs are to be engaged. Earlier notification was issued by Central Railway on the same subject matter dated 16/07/2020 for engagement of 18 CMPs. In continuation, it is required that these 18 posts of CMPs are to be kept filled to maintain effective strength of doctors. Hence, Walk-in-interviews / Online video call interviews will be held to engage CMPs from open market on full time **contract basis** who fulfils the eligibility criteria specified below for a period of 3 months from the date of their joining or till 31/12/2020, whichever is earlier.

The engagement will be offered purely on contract basis for a **period of 3 months** from the date of their joining or till 31/12/2020 or till further orders whichever is earlier. Preference will be given to those, who can join immediately to Dr. B.A.M. Hospital/Byculla, Mumbai.

- a) Since the posts are over and above the sanctioned cadre due to the exigencies on temporary measure, no prescribed community distribution (SC/ST/OBC) is applicable. However, age relaxation will be given to candidates belonging to SC/ST/OBC category as per extant rules. Age will be reckoned as on the date of notification.
- b) Engagement of doctors on contract basis will be continued till required number of doctors are maintained (i.e. 18) on over and above the sanctioned strength as per the need.
- c) If more doctors are available, then a panel would be kept ready for replenishing the vacancy which may arise till 31st December 2020. - 3) CMP's doctors, who enter into contract with the railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract. Services rendered as fulltime contract Doctors will not have any bearing in respect of considering of their period in regular selection through UPSC, nor will it confer them any right for regulations or absorption upon.
- 4) Eligible SC/ST/OBC candidates may apply along with necessary caste certificate. OBC candidates have to submit certificate in Central Government format to the effect that they do not belong to Creamy Layer, from appropriate authorities.

- 2 Candidates should have satisfactorily completed the compulsory rotating internship.

(E)Doctors serving under State/Central Govt/ Public sector undertaking etc may apply with NOC from the respective organization.

- **(F) Doctors** while applying should indicate past service rendered, if any including the period of contract put in by them on all over Indian Railways.
